As per Notice No. 2, the Centralized Admission Process (CAP) Round 2 for admission to Diploma in Psychiatric Nursing (DPN) and Public Health Nursing (PHN) was completed on 25/08/2025. Important Instructions for Candidates :

1. Candidates should verify the fee structure of in the information brochure before filling in their choices/preferences.
2. Candidates who have been allotted a seat in Round 3 or any subsequent CAP round and wish to seek betterment must first report to the allotted college and complete the admission process.

3. Candidates who want betterment should not fill the "Status Retention Form".Once Status Retention Form filled it cannot be reverted.
4. All candidates participating in CAP Round 3 are required to fill fresh choices/preferences for this round. If candidate does not fill choice/preference he will not be considered for CAP round 2.
5. Choices/preferences submitted in previous rounds will be null and void and will not be considered for CAP Round 2 seat allotment.
6. If a candidate fails to report and join the allotted college within the prescribed time period, they will not be eligible for any further CAP rounds.
7. If any candidate is satisfied with the allotment and wants to confirm the admission, they should fill out the Status Retention Form. The college shall not force any candidate to fill Status Retention Form.
