The Medical Counseling Committee, New Delhi has revised the schedule for All India Quota (AIQ) and State Quota Counseling. Accordingly the Schedule published in Notice No 04 & 05 stands revised.

In view of this, the last date for Joining of CAP Round 3 and the registration of newly eligible candidates has been extended as per the revised schedule. The revised counseling schedule is as follows:

Note : For ensuring faithful obedience of time schedule and also keeping in view the limited time available for conducting counselling, all participating institutes/ colleges are directed to treat all Saturdays/ Sundays and Gazetted Holidays as working days.

Important Instruction :

- 1) Candidate will be allowed to fill preferences of Government/ Corporation/ Government Aided / Unaided Private and Minority Institutions depending upon the deposit amount the candidate has paid during registration.
- 2) As per MCC information brochure clause 14.11.9 candidates Allotted a seat in All India Round 3 shall not be eligible for any further counselling rounds of State Counseling. Candidates should take note of the same.
- 3) Candidates allotted a seat through State counselling Round 3 will have to JOIN the allotted seat and they will not be eligible for any subsequent round(s). Names of candidates allotted a seat in CAP Round -3 will be shared with MCC.
- 4) The Filling of Status Retention form is choice of the candidate. However, Status retention form once filled cannot be taken back. Hence, candidates should be careful while filling the status retention form.
- 5) **NRI candidate should register on [Foreign Candidate Registration Portal](#) before 22/08/2025 for verification of candidate's eligibility. The subsequent schedule will be as above.**
- 6) Fee payment through Cheque is allowed on Sunday & Bank Holidays. However, they have to be replaced with DD immediately on the next working day.
