**Revised Schedule for CAP Round - 4 for
BAMS/BHMS/BUMS Courses (Group -B) only A.Y. 2025-26**

The MBBS/BDS rounds were delayed as per the schedule of MCC. It was noticed that many higher merited candidates of Group B taken admission to MBBS/BDS courses thereby leaving government/government aided seats vacant after round 3 of Group B. These seats could have been allotted to lower merited candidates in Online Stray Vacancy Round.

In view of the above position and requests received from candidates, the State Government has decided to conduct CAP Round -4 and allow betterment for all candidates of Round-3 of Group B. Therefore, in supersession of the notice no.29, following schedule for CAP round -4 may be referred.

The above schedule is subject change as per the direction of various authorities like MCC / AACCC / Central Government / State Government / Hon'ble Court.

Note : For ensuring faithful obedience to time schedule and also keeping in view the limited time available for conducting counselling, all participating institutes/ colleges are directed to treat all Saturdays/ Sundays and Gazetted Holidays as working days.

Instructions :

- 1) Candidates joined in Group A (MBBS/BDS) are not eligible for Group B subsequent rounds.
- 2) Candidates allotted a seat in CAP-3 and subsequent rounds of All India Counseling conducted by MCC, AACCC and State (AIQ) will not be considered for allotment in this round and subsequent rounds.
- 3) All the candidates allotted a seat in CAP -3 are eligible to fill choices as per schedule above.
- 4) Candidates who wish to retain the joined seat shall not fill the preference. If candidates who have already filled retention during round 3 fill the preferences. Their retention will be deemed to be cancelled.
- 5) It is mandatory to join the allotted seat in this and subsequent rounds (if any). Hence candidate should fill only those Preference/choices for which they are ready to take admission, if allotted.
- 6) Candidates are advised to verify and ascertain the fee structure before filling the preference/choice.
- 7) It is responsibility of the candidates to submit all original documents and necessary fees in the form of DD/Cheque/NEFT/RTGS at the time of admission. **Fees can be paid by Cheque only on Holidays to be replaced by DD on next working day.**
