❖ **Not Eligible for Registration :**

1. Candidates who have joined status for BPTH/BOTH/BASLP/B P&O/BNYS (Group C) courses.
2. Candidates who have joined seat in Round 1, Round 2 , Round- 3 & Stray Vacancy Rounds of State Counselling seats for MBBS/BDS/BAMS/BHMS/BUMS Courses or All India Quota Counselling .
3. Candidates were part of eligible candidate list for Institute level round but have not joined in any institute, need not register again.
4. Candidates who had failed to re-register themselves during CAP Round 3, and now wish to participate shall register themselves during this period.
5. Candidates cannot cancel their seat now and register again to participate in Institute Level Round - 2 to be declared in due course.
